- With ODE, WebXam used to deliver tests for CTE workforce and related programs (FCS)
 - Includes delivery of assessments based on FCS 2007 standards document and course structure (ODE)

Brief OCTCA/WebXam History

- OCTCA (Ohio Career Technical Competency Assessment) is the statewide testing system for Career-Technical Education in Ohio
 - Introduced in 1993-1994 (OVCA, with OCAPs)
 - Web-based testing (WebXam) began with Information Technology tests in 2001
 - In 2012-2013, over 50,000 students took tests.
 - About 50 different assessment sequences
 - Workforce Development (WFD): 14 of the 16 Ohio career fields
 - Family and Consumer Science (FCS)

Types of CTE Assessments

- WFD End-of-program / 100-item
 - Slowly being phased out
- WFD Modular sequence
 - Increasingly based on courses defined by ODE
 - Transition to end-of-course began with Agriculture, now all new tests
- Teaching Professions portfolio – rubric-scored
- FCS end-of-course 50-item

What's new for 2013-2014

- New student testing page in January
- Students can be assigned to more than one teacher
 - Instead of **moving** students from one teacher to another, students can be **reassigned** to a new teacher or **unassigned**.
 - Any number of teachers can be assigned to student when editing student.
 - Data uploads will add teacher to existing student account.
 - When activating tests, administrators pick a teacher.
- Still in development:
 - Report on multiple tests at once
 - Finer grain reporting for FCS assessments

How the System Works

- Hierarchical, secure, with logins and passwords
 - DTC → Teacher → Student
- DTC (District Testing Coordinator) is main point of contact for district
 - Because the career center in a CTPD is accountable for career-tech performance in CTPD school districts, the career center DTC is often set up as DTC over the users in those school districts.
- Teachers or administrators can manage student accounts
- Students are activated for tests
- Students complete-submit tests, results returned immediately
- Multiple report formats; data is immediately available
- Minimal system requirements: web browser

EMIS ID

- All students must be entered into WebXam (either manually or via upload) with an “EMIS ID”.
- The EMIS ID
 - is a locally-derived identification number (usually the student’s ID in the district’s Student Information System).
 - should not be the SSID or Social Security number.
 - should be consistent for a student from one year to the next.
 - This ensures that when a new upload file comes, a new student account is not created when the student already exists.
 - should be unique within the district.

Common Test Activation Problems

- (More details to follow in walkthrough)
- Check that:
 - ❑ student account is created.
 - ❑ student account is under teacher or administrator doing activation.
 - ❑ student account is enabled.
 - ❑ student account has the correct assessment assigned to account.
 - ❑ student has not already taken the test this year.

Testing Environment

- Assessments are timed: # minutes = # items
- Proctor required: “Any responsible staff member other than the student’s teacher of record associated with the program area being tested may serve as the test proctor.”
- Students cannot use external reference material, resources, or devices with the following exceptions:
 - Four-function calculator
 - Scrap paper that is later collected
 - Any tool or device specified in a student’s IEP or 504 Plan.
- Testing Security Rule Book available on WebXam website
- Not permissible to disseminate content or share with students

Testing Irregularities

- WebXam stores each response as it is entered along with the time remaining.
- In case of a test interruption, like a fire drill or computer problem, students can be set up to resume the test at a later time
- Any alleged assessment security violation should be reported to ODE.

What is covered on the assessments?

- 100-item and FCS assessments cover entire set of standards for course or pathway
- For modular assessments, each module covers a subset of the content standards for the pathway.
- For end-of-course modular assessments, the module covers the course as defined by the Ohio Department of Education.
- Look at module document on WebXam website (not updated yet for 2013-2014)

Rules for Modular Testing

- Can a student retake a test?
 - A module, end-of-program, or FCS end-of-course assessment can be taken once per school year.
 - Student's overall score is reported for entry into EMIS every June.
 - As of FY2013, if a module is retaken, the highest score is used when calculating the overall score. (Previously, the most recent score was used.)
- How many modules do I take?
 - Most non-end-of-course tests: all modules
 - Arts & Communication: Take modules 1-4 and one of 5,6,7
 - Agriculture end-of-course tests: one for each course; not less than 3
 - Upcoming end-of-course tests: see upcoming Field Test Memo

Who should test?

- WFD assessments are used for the measurement of Technical Skill Attainment – the 2S1 measure – for Perkins reporting
- All CTE Concentrators with a required assessment should test.
- Students with IEPs can be set up with accommodations
 - Additional time
 - Reader is required (items are unscrambled but district provides audio)
- Proficient score is used in 2S1 measure – not advanced score
- A proficient score does not necessarily meet the requirements of a given postsecondary articulation agreement

Relationship between ITCs and Districts

- In the past, almost all districts used an ITC for student data uploads.
- All districts continue to use ITCs for score downloads
- Districts now have the option to handle student uploads without going through the ITC.
 - Log on to WebXam.
 - Secondary Students -> Upload
 - Get Excel template, fill it out, and upload it
(or use an export from a Student Information System like DASL).

ITC and WebXam Data Exchange: Uploads

- Log on to WebXam at www.WebXam.org.
- After logging in, ITC staff uploads a data file.
- WebXam staff will process the data file and add new students within 5 business days.
- Notification sent to district and ITC.

ITC and WebXam Data Exchange: Uploads

At any time prior to the yearly deadline, school districts can request an upload of student data from an ITC to WebXam.

- Uploads not available after April 11, 2014 deadline due to CETE/OSU staff time tied up in WebXam Support.
- Students can always be added manually using a form on the website.

ITC and WebXam Data Exchange: Uploads

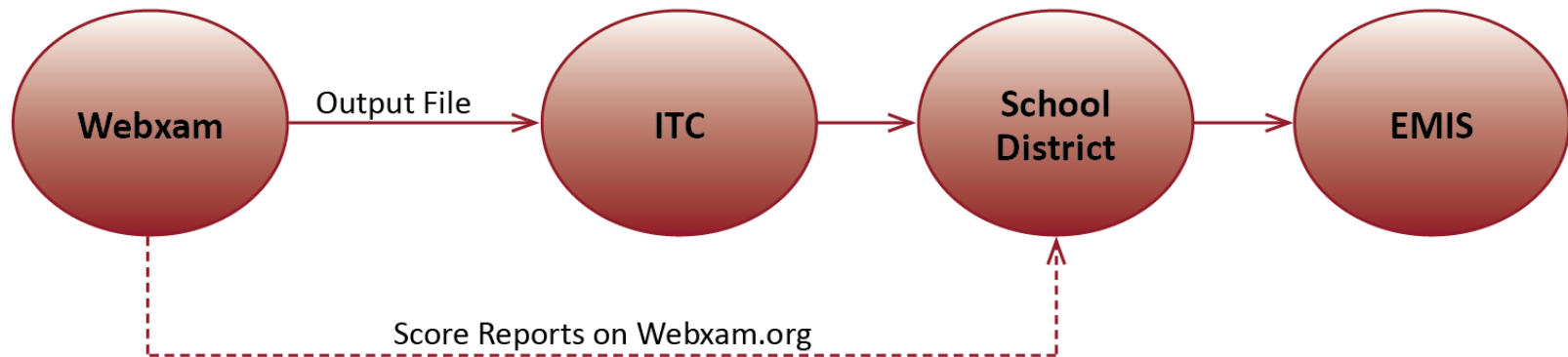
- Assessments are added based on CTE Program of Concentration or FCS assessment.
- If we cannot determine the assessment, we contact district for clarification.
- Students must be assigned a teacher. If no teacher is provided, we contact district for clarification.
- To avoid duplication, existing students will not receive a new WebXam account. Grade level, assessment, and assigned teachers will be updated.

Score Downloads - FCS

At this time, FCS scores are not included in the yearly output for the state's EMIS data system. District staff can download scores from the WebXam website.

Score Downloads - WFD

During the first week of June, WebXam staff will notify the ITCs that files (the “output files”) are available for download. The file structure has been set up specifically for entry into EMIS.

ITC and WebXam Data Exchange: Downloads

- June 1-15, WebXam staff notifies ITCs that files (the “output files”) are available for download – DTC is also notified
- ITC staff log in to WebXam to download output files.
- Data includes the student name, EMIS ID, 4-letter form ID of assessment taken, percentage score, and pass/fail indicator.
- There is one download file per district. The filename is the IRN.
- Only students who tested during the school year ending are included.
- All students who tested are included, regardless of grade level.

Use of data in EMIS by ODE

- Districts report scores to EMIS.
- A score in WebXam is used for the measurement of Technical Skill Attainment (Perkins 2S1) if and only if the student is reported as a CTE Concentrator.
- If a score is reported before the student is a CTE Concentrator, ODE will hold the score until the student becomes a CTE Concentrator.
- If scores are reported over multiple years, as long as one score is passing, the student is considered passing.

The WebXam Reporting System

- Results are available immediately after tests are submitted
- All reports are created “on the fly”
- Multiple reporting options
 - Roster Report
 - Individual Report
 - Aggregate Report
 - Testing Summary

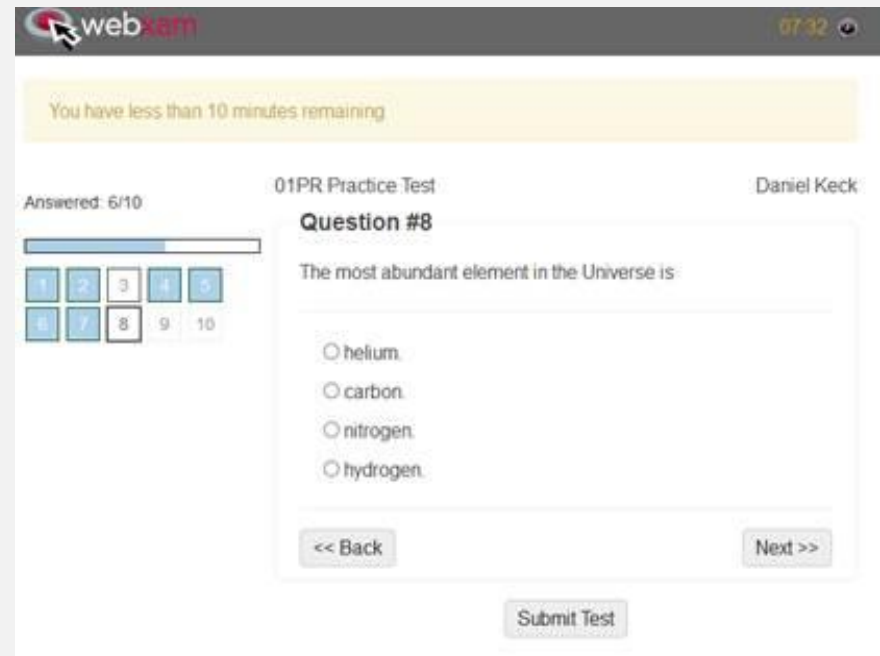
