### **Brief History of Ohio CTE Testing and WebXam**

- CETE is a research center at The Ohio State University.
- Developing and delivering Ohio CTE tests since 1993; online tests since 2001.
- In 2013-2014, approximately 55,000 students took Ohio CTE Pathway Tests, Family and Consumer Science tests, or Teaching Professions (portfolio scoring-reporting system)







# **Ohio CTE Pathway Test Structures**

### End-of-program / 100-item

- Only one test per student.
- Transportation only

### Modular sequence

- Test broken up into modules. Students must take all modules (except for Arts students).
- Arts and Communications, Business, Education, Finance, Hospitality, IT, Marketing

### End-of-Course (EOC)

- Students take an EOC Test for each CTE Course taken.
- Students not expected to take all available EOC Tests.
- Agriculture, Construction, Engineering, Health, Human Services, IT, Law and Public Safety, Manufacturing, Transportation

### Teaching Professions portfolio

Rubric scored-stored







### Other Tests in WebXam

#### FCS end-of-course 50-item

- Not reported in EMIS.
- No charge to districts

### Employability

- Not required by the Ohio Department of Education.
  - TWO forms available (100, 80 items)
- \$9 charge per student per test.







# **Types of Tests by Function**

### Operational test or Operational posttest

- This is the standard type of test normally given in WebXam.
- Scores included in end-of-year score report to EMIS.
- Passing status available immediately on test completion.

#### Field tested test

- Entire item bank included in EoC Test, so tests are large (80-100 items).
- Represents first one or two years of a test's lifetime.
- Passing status not available immediately on test completion.
- In May of first or second year of field testing, operational test forms of 40 items are chosen based on instructor judgments and student testing results.
- Students will then receive a passing status on EOC Tests taken earlier.







# **Types of Tests by Function**

#### Pretest

- As of 2013, 2014, CETE is contracted to write extra items for EoC Pretests.
- Cost of delivery is \$1 per student per EoC Pretest.
- Districts are **not required** to take pretests in WebXam. It is offered as an option for Teacher Effectiveness requirements.
- Pretest and posttest scores will be used to report Teacher Effectiveness Ratings by May 1.

#### Practice test

- As of 2014-2015, CETE is contracted to write extra items for Pathway-specific Practice Tests.
   These will be released after field testing is complete, starting with the current new tests
   (Human Services, IT, Transportation.)
- So, the first Practice Tests will be available in 2015-2016.
- o For now, there is a generic Practice Test that can be used to acclimate students to WebXam.

### What's new for 2014-2015

 New scoring scheme: Dynamic performance standards based on courses taken

Previously, 03MC had a fixed pass-fail performance standard of 54 (left column).

Problem: Students pass all End-of-Course Tests but fail Pathway Test.

Now, pass-fail score will be average of performance standards for End-of-Course tests taken.







### What's new for 2014-2015

We have changed how tests are selected.

- 1. All students must be assigned a Pathway Test.
- 2. Students are assigned one or more EOC Tests (if applicable)
- 3. However, that Pathway Test can be changed anytime before the student graduates.
  - Any EOC Tests valid for the chosen Pathway Test will be used.
  - Example: 010115 Business Management is an available course for all Agriculture Pathways.
  - Student takes 03MC 010115, but if the student switches to the 08MC, the score is used as 08MC 010115.







### What's new for 2014-2015

#### Available now

- Pretests for selected End-of-Course tests (~38)
- Added subject code to End-of-Course tests.
- District administrators can view and modify hierarchy of staff in WebXam.
- In most places where a teacher or test needs to be selected, users can now type part of the name to get a match.

### In progress

- Finer grain reports groups of Outcomes
- Reporting on multiple tests or multiple years at once
- Student upload process giving more control to district WebXam users







### Overview of WebXam

- Hierarchical, secure, with logins and passwords
  - DTC → Administrator → Teacher → Student
  - Students can be assigned to more than one teacher.
- DTC (District Testing Coordinator) is main point of contact for district
  - Because the career center in a CTPD is accountable for career-tech performance in CTPD school districts, the career center DTC is often set up as DTC over the users in those school districts.
- Teachers or administrators:
  - manage student accounts.
  - activate students to take tests.
  - can see reports immediately after students submit tests.
- Minimal system requirements: web browser







### **EMIS ID**

- Required for all student accounts in WebXam.
- A locally-derived identification number
  - Usually the student's ID in the district's Student Information System
- Should not be the SSID or Social Security number.
- Should be consistent for a student from one year to the next.
  - This ensures that when a new upload file comes, a new student account is not created when the student already exists.
- Should be unique within the district.
- Can be added via uploads or manual student entry.







### **Common Test Activation Problems**

### Check that:

- □ student account is created.
- □ student account is under teacher or administrator doing activation.
- □ student account has the correct test assigned to account.
- □ student account is enabled.
- ☐ student has not already taken the test this year.







# **Testing Environment**

- Tests are timed: # minutes = # items
- Proctor required, who
  - must be a paid employee of the school district.
  - o must not be a student, student teacher, or unpaid volunteer.
  - must not be a teacher of the pathway or course being tested.
  - does not need to be registered in WebXam.
- Teacher may be present in room to assist with technology and managing student interactions, but should not observe computer screens of test takers.
- Students cannot use external reference material, resources, or devices with the following exceptions:
  - Four-function calculator
  - Scrap paper that is later collected
  - Any tool or device specified in a student's IEP or 504 Plan.
- Testing Security Rule Book available on WebXam website
- Not permissible to disseminate content or share with students







# **Testing Irregularities**

- WebXam stores each response as it is entered along with the time remaining.
- In case of a test interruption, like a fire drill or computer problem, students can be set up to resume the test at a later time
- Any alleged test security violation should be reported to the Ohio Department of Education.







### What is covered on the assessments?

- End-of-program / 100-item
  - Entire set of standards for course or pathway
- Modular sequence
  - Each module covers a subset of the content standards.
  - Refer to Available Test page in WebXam Information Resources.
- End-of-Course (EOC)
  - Students take an EOC Test for each CTE Course taken.
  - Refer to Course Descriptions and Sample Course Outlines on ODE's website.
    - Sample Course Outlines include the Outcomes and Competencies covered.

### Can tests be retaken?

### End-of-program / 100-item

- Can be taken once per school year.
- Each result is reported. The Ohio Department of Education is looking for one passing score.

### Modular sequence

- Each test can be taken once per school year.
- If a test is retaken, the most favorable score is kept (i.e., the best score compared to the performance standard for that school year).
- Any module not taken will be counted as a zero score.

### End-of-Course (EOC)

- Each EOC Test can be taken once per school year.
- If an EOC Test is retaken, the most favorable score is kept (i.e., the best score compared to the performance standard for that school year).
- Students should take the EOC Test for each course taken. Any Pathway Test with fewer than three EOC Tests will be reported as Incomplete.







### Who should test?

- Ohio CTE Pathway Tests are used for the measurement of Technical Skill Attainment – the 2S1 measure – to meet the requirements of the federal Carl D. Perkins Career and Technical Education Act.
- All CTE Concentrators with a required test should test.
- Students with IEPs can be set up with accommodations.
  - Additional time
  - Reader is required (items are unscrambled but district provides audio)
- Proficient score is used in 2S1 measure not advanced score
  - A proficient score does not necessarily meet the requirements of a given postsecondary articulation agreement

### ITC and WebXam Data Exchange: Uploads

### When can I upload students?

- At any time prior to the deadline, school districts or ITCs can submit an upload file of student data to WebXam.
- Uploads not available after April 11, 2014 deadline due to CETE/OSU staff time allocated to WebXam Support.

#### Directions

- Log on to WebXam at <u>www.WebXam.org</u>.
- After logging in, district staff or ITC staff upload a data file.
- WebXam staff will process the data file and add new students within 5 business days.
- Notification sent to district and ITC.

### What if I miss the upload deadline or leave out a student?

Students can always be added manually using a form on the website.







### ITC and WebXam Data Exchange: Uploads


- Tests are added based on CTE Program of Concentration or FCS test.
- If we cannot determine the test, we contact district for clarification.
- Students must be assigned a teacher. If no teacher is provided, we contact district for clarification.
- To avoid duplication, existing students will not receive a new WebXam account. Grade level, tests, and assigned teachers will be updated.

### ITC and WebXam Data Exchange: Downloads

#### When can I download score data?

- By June 12, 2015, WebXam staff notifies ITCs that the score output files are available for download. The DTC is also notified.
- ITC staff log in to WebXam to download output files.
- (Score reports are also available for download anytime on the WebXam website.)

### File setup

- Data includes the student name, EMIS ID, 4-letter form ID of Pathway Test taken, percentage score, and pass/fail/incomplete indicator. (Incomplete for Pathway Tests with EOC Tests only).
- o There is one download file per district. The filename is the IRN.

### Data

- Only students who tested during the school year ending are included.
- o All students who tested are included, regardless of grade level.
- Family and Consumer Sciences tests are not included in the score output files.







### Use of data in EMIS by the Ohio Department of Education

### What is reported to EMIS?

- Districts report Pathway Test scores to EMIS, ODE's student data system.
- EOC Test scores and module scores are not reported to EMIS.

### What if a student tests during multiple years?

- If a Pathway Test score is reported before the student is a CTE Concentrator, the Ohio Department of Education will hold the Pathway Test score until the student becomes a CTE Concentrator.
- If Pathway Test scores are reported over multiple years, as long as one Pathway Test score is passing, the student is considered passing for the 2S1 Perkins indicator.
- A Pathway Test score is used by the Ohio Department of Education only if it is a student is a Concentrator in a matching CTE Program.

### What if the student leaves?

A student's test score is only used if the student becomes a CTE Concentrator.







# The WebXam Reporting System

- Results are available immediately after tests are submitted
- All reports are created "on the fly"
- Multiple reporting options
  - Roster Report
  - Individual Report
  - Aggregate Report
  - Testing Summary


